# Online membership registration and class selection for current members

Using a browser, go to our web site https://www.pooleu3a.org.uk/ where you will find a link to register for Poole u3a as a **current member**.

To renew your membership online you need to use the Members Portal

The first time that you access the Portal you will need to register for a new Members Portal account. This is a one-off requirement - thereafter signing in will require your email address and password only. Before you start make sure you have your membership number to hand.

The first time that you access the Portal you will see the following screen. Do not enter an email address or password initially. Click **Register for a membership account**

Type in your Membership number, Forename, Surname, Post Code and email address, then press **Confirm Identity** 

You will now be asked to create a password for your Members Portal account. Please make sure you note this as it will be needed to access your account in future.

You will be sent an email with a link. The confirmation email will expire after 1 hour, although **Forgotten Password** can be used to request a new confirmation email.

Clicking the link in the email will take you back to the sign-in screen where there will be a message to say that your email address has been verified.

After entering your email address & password, press Confirm Identity

You will now see the following screen.



This enables you to register for Poole u3a for the following year. Please continue to do this.

## Click 'Renew your membership'

You will now see a screen below. The amount will be either £25 or £12 depending on your status.
